I/we, the undersigned, give permission for our child to attend – Timber-lee 2024 - with NorthBridge Church, and I/we give permission for the leaders to administer any emergency medical attention that my child may need for the trip/event. I also agree to ensure my child's medical information form has been completed and submitted to their ministry leader before the event/trip.

I/we recognize that inherent risks are involved in church sponsored/organized activities and will hold harmless and indemnify any person involved from any injuries that our child sustains during the activity.

I/we give permission for our child to be treated by a physician or other health care professional, for the said health care professional to administer the necessary care for our child, and agree that in emergencies, it may not be possible to contact a parent before treatment but that we will be contacted as soon as possible.

Due to my child's participation in this activity, I/we hereby take action for above child/children, their executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I/We waive, release, and discharge from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for above named child death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this activity, the following entities or persons: NB Church and/or their elders, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers;

(B) indemnify, promise not to sue entities or persons in this activity, and hold harmless from all liabilities or claims made as a result of participation in this activity, whether caused by negligence or release or otherwise.

I/We agree NorthBridge Church, its staff, elders, volunteers, representatives, and agents are NOT responsible for errors, omissions, acts, or failures to act of any party or entity leading a specific activity on its behalf.

I/we also give permission to NB Church and its agents to take photos, videos, and other media of my child participating in various activities and agree to hold harmless and indemnify NB Church and its agents of all liability. These files may be used by NB Church in online and/or print publications during/after the event.

I/we understand that, while my child participates in this church sponsored activity, he/she is responsible to abide by the rules set forth by the church, its leaders and supervisors. Any serious infraction of these rules and/or lack of cooperation with leadership by the child/children can result in the dismissal from the activity (including the possibility of calling parents to pick up children at any time day or night). If a student is dismissed from the activity, I agree to assume the cost of travel home, and any damages caused by the child.

I/we agree to allow my child to ride in any vehicle driven by an approved adult leader to attend and/or participate. We agree that SEAT BELTS MUST BE WORN AT ALL TIMES and that students must comply with driver requests or be dismissed from the activity at the sole discretion of the NB Church leader responsible.

I/we agree to all statements included for all children in our family listed above by signing this form.

I/we agree that by signing this form, I have the legal authority to give permission for my child to participate in the event above and that if another parent/legal guardian must give consent that I have either gotten their verbal consent or signature below in addition to my own. (All students under the age 18 participating in student ministry events at NorthBridge Church must have parental consent in order to participate.)
